Depositions taken this 24th day of July 1779 respecting the right of Moses Stainton has to the water to his mill from Shirbock in bottom of Windor.

Darce Curwen aged 70 says he farmed a tenement of Henry Walthorm situated at Wilton and lived there 23 years, which he left about 19 years agoe - that where the weir is erected across the river Korbock buts against that part of the tenement he farmed, and that during all the time he farmed and lived there he never knew any disturbance or molestation given to Moses Stainton or the occupier of his mills in the erecting or repairing the water weir to carry the water to his mills, save and except some boys who had come to dam the water for catching fish.

Darcy Curwen

Henry Herd of Wilton aged 73 says he was born at Haile, says he has lived at Wilton for 50 years, that formerly the ground where the water weir is erected across Tarbocke lay in common but is now divided and that part alloted to Henry Walker, that during all this time he frequently and often had an opportunity of seeing this weir, and that he during this time never saw any or heard of any disturbance or molestation given to Moses Stainton or the occupier of his mills in respect of this weir from any person whom so ever save and except and within this year last past. That he remembers about 37 years ago he was at Moses Stainton's mills with a little corn to grind that whilst he was there John Ponsonby of Hail Esquire grandfather of the present Miles Ponsonby Esquire Lutridge came there it being a dry season of the year Mr. Ponsonby was (and Mrs Lutridge) scarce of water to their mills, that they were going to pull down Moses Stainton's water weir across Thorbock but that they had a mind to speak to Moses first, and see his title and writings if he had any, upon which Moses Stainton very readily brought them his writings, and called him to see that he delivered his title deeds to them, which they presused and read, and then returned them to Moses Stainton again, that he very well remembers when Mrs. Ponsonby and Mrs Lutridge was going away hearing Mrs Lutridge say it was very well they came to see Stainton's writings before they went to pull down the weir for that he did not expect to find or have seen such a title in any persons resting., that he remembers Mr. Ponsonby's mills standing in a different situation to what the present mill does, where she had no benefit from the water of Thirbeck.

Henry Hird.

Henry Noble aged 67 years says he was miller at Mr. Ponsonby's mills 22 years and that he left it about 20 years ago, that during all that time he never did or had diversion to go and pull down or disturb Moses Stainton or the occupier of his mills in the quiet possession or use of the water to his mills out of Thirbeck, that he remembers the removing the old mill from a rising ground about 60 or 80 yards to the East of the present mill which mill had no benefit from the water of Thirbeck and the building of the present mill, which is about 46 years ago.

Henry Noble.

William Haile aged 83 years says he was servant with Mr. John Ponsonby of Hail about 60 years ago, at that time the mill belonging to Hail was and stood upon a rising ground from the present mill and at that time had no despondence of water from Thirbeck, that he was a srvant with one Isaac Grayson of Egremont about 68 years ago, that his master had a flock of sheep which which often occasioned him to go and look after them that the sheep used to go and pasture in a place called Cowfield Bottom near where Moses Stainton takes his water out of Thirbeck that the mill race to Moses Stainton's mill and weir was the same then as at present that he never heard of any disturbance being given to the erecting of the weir or the taking the water out of Thirbeck.

William Haile

Paul Asslock about 72 years of age says he was servant with John Ponsonby of Hail Esquire about 50 years ago, at that time the mill belonging to Hail Hall stood upon rising ground from the present mill and had no despondence of water from Thirbeck. That he was srvant about 42 years ago with Moses Stainton at that time he had and did in a day season often go to a place where his master Stainton took the water out of Thirbeck to his mill and re---ered the weir in order to get more water.

Paul Asslock, his mark.

John Horing about 70 years of age, says he was servant with Moses Stainton about 40 years ago and that he lived with him about 2 years - during that time he often went to the weir across Thirbock to repair it after a flood or in a dry season and that he never heard of any disturbance being given to Moses Stainton for taking water out of Thirbock to his mill by anybody that one time he was sent by his master to repair the weir after a flood and that he hired three men from Wilton to assist him.

AND WHEREAS upon an account stated and settled between the said Henry Bacon and Moses Stainton there was due to the said Henry upon the said mortgaged premises for principal and interest the sum of £210 ... and he the said Henry having occasion for his money desired and purchased with the said Thomas Leech to accomodate and advance this the sum of £210, taking and assigning the said mortgage to the said Thomas Leech... thereupon the said <u>Henry Bacon</u> by indenture dated 9th December 1779 made between Henry Bacon of the one part and and the said Thomas Leech of the other part ... the premises were transferred and assigned to the said Thomas Leech ... to have and to hold to him and his heirs and assigns forever...
